# THE SCHEDULE OF APPROVAL

## 1. PRODUCT DESCRIPTION:

# A-0 Class Circular Non-Opening Sidescuttle, type "A0 Circular Fire Class Side Scuttle"

The min.75 mm deep circular window is composed of:

main frame:

housing frame:

fire glass assembly:

12 mm thick and min.70 mm deep steel plate,
30 mm wide and 10 mm thick steel plate,
34 mm thick (see details below),

- glass retaining frame: 45~50 mm wide and 5 mm thick steel plate.

The window has been tested in an A-60 class bulkhead with insulated side exposed to fire.

From the side exposed to fire, the fire glass assembly type "Contraflam Lite Marine DGU A0" (total thickness 34 mm; manufactured by Contraflam) is composed of:

- 16 mm thick pressure glass (5 mm thick tempered glass + thermo-expanding gel + 5 mm thick tempered glass),
- 12 mm thick air gap,
- 6 mm thick tempered glass.

#### Means of fixation:

- between main frame and bulkhead: by continuous welding on both sides,
- between main frame and housing frame: by continuous welding on unexposed side,
- between main frame and glass retaining frame: M6x16 mm steel screws with a 70 mm spacing.

## Heat insulation and glass gaskets filled in between fire glass assembly and window frames:

- between main frame and glass perimeter: 2 mm thick intumescent seal type "Flextrem 100" and 50x20x5 mm spacers (setting blocks) type "Promatect H",
- between fire glass assembly and housing frame and glass retaining frame: 3 mm thick (30x6 mm) ceramic fiber type "Kerafix".

Maximum frame dimensions: Ø1850 mm (diameter)
Maximum clear light dimensions: Ø1750 mm (diameter)
Maximum size of the fire glass assembly: Ø1800 mm (diameter)

Thickness of the fire glass assembly: 34 mm Depth of window: min.75 mm

## 2. DOCUMENTS AND DRAWINGS:

As per the Manufacturer's drawings N° A-0 C.001 Rev.3 dated 03/01/2024 and N° A-0 C.002~C005 Rev.2 dated 01/07/2019.

## 3. TEST REPORTS:

Test report N° 2010CS012147/3 dated 06/08/2010, as per IMO FTP Code Annex 1 Part 3 [test standard: IMO Resolution A.754(18)], from RINA, Italy.

## 4. APPLICATION / LIMITATION:

- 4.1 Not-approved for A-class protection against fire from the weather side (e.g., not for use on front bulkhead of tankers).
- 4.2 Installation on board ships carrying liquefied gases in bulk is subject to limitations given in paragraph 3.2 of IGC Code.
- 4.3 The side scuttle has only been evaluated with regard to its fire resistance. The arrangement and location of any window in respect of strength requirements are subject to approval in each case.
- 4.4 Sidescuttles of same type with lesser dimensions in terms of height and width than tested and with the same or greater thickness of [glass pane or panes and gaps] than tested (see §1) are also covered by this certificate.
- 4.5 The fitting aboard should be the same as used for the test.

# **5. PRODUCTION SURVEY REQUIREMENTS:**

5.1 - This certificate alone does not allow the applicant to issue the UK Declaration of Conformity and to affix the mark of conformity (United Kingdom conformity mark) to the products corresponding to this type. To this end, the production-control phase module D Production Quality Assurance or module E Product Quality Assurance or module F Product Verification of Schedule 2 of the Merchant Shipping (Marine Equipment) Regulations 2016, as amended, is to be complied with and controlled by a written inspection agreement with an Approved Body.
